Entry declaration: I the undersigned apply to enter the event described overleaf and in consideration thereof: - I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.

I further, declare that I am physically and mentally fit to take part in the event and I am competent to do so. I confirm that I am not currently suspended from ACU permitted competition or on the ACU STOP LIST as a result of incurring a Concussion/Suspected Concussion injury

I confirm that I understand the nature and type of event I am entering and its inherent risks and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organisers or officials.

I accept that insurance arranged on my behalf by the organisers of events that I may enter specifically excludes liability between the participants. I understand that this form may be used in litigation as evidence that any serious injury will be principally the result of my voluntary decision to engage in a high-risk activity.

I consent to details of any injuries I may suffer at this event being passed between all medical services and the Clerk of the Course.

I consent to the collection and retention of my personal information by the ACU.

I confirm that if any part of the event takes place on a public highway, the machine(s) described below shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that it / they will comply with the regulations in respect thereof. I/We confirm that I/We are not suspended from competition in ACU permitted events.

I confirm that the machine(s) as described overleaf, which I participate on shall be suitable and proper for the purpose. I/We confirm that I/We are eligible to compete on the machines for which I/We have entered.
